#### ASSUMPTION OF RISKS

I agree to assume all risk, dangers and hazards of participating in all Club Activities including but not limited to: Skiing, boarding, riding, disembarking ski lifts; failure of ski lifts; changing weather conditions; variation or steepness; avalanches; exposed rock, earth, ice and other natural objects; trees, tree wells, tree stumps, forest dead fall; the condition of snow or ice on or beneath the skiing surface; changes or variations in the snowboarding terrain which may create blind spots or areas of reduced visibility; changes or variations in the snow surface or sub-surface; negligence of other skiers; loss of balance or control; property loss or damage, slips, trips and falls; collision or impact with natural or man-made objects or with other persons; becoming lost or separated from one's party; failure to act safely or within one's own ability or within ones own ability or stay within designated areas; travel within or beyond the ski area boundaries; and negligence on the part of Love to Ski Club Inc. and its' directors, officers, employees, ski and snowboard instructors, guides, volunteers, agents, independent contractors, subcontractors, representatives, sponsors, successors and assigns (hereinafter collectively the "Releasees"). I understand that negligence includes failure on the part of the Releasees to take reasonable steps to safeguard or protect me from the risks, dangers, and hazards of participating in all Club Activities.

I understand that precautionary measures may be required to protect myself and other participants from the risk of a contagious disease, such as the COVID-19. I waive all rights to pursue recovery related to any virus, bacteria, disease, or contagion. I undertake to follow all applicable legislative, regulatory, or governmental guidelines and requirements which may be applicable at that time, as well as any other guidelines or procedure put in place by Love to Ski Club Inc., and/or the individual ski areas, to ensure my safety and the safety of other participants.

## RELEASE OF LIABILITY

I agree that any litigation involving the Releasees shall be brought solely within the Province of Ontario and shall be within the exclusive jurisdiction of the Courts of the Province of Ontario.
